## Acceptable Use Policy Internet and Technology Use

#### **Acceptable Computer Use**

- Do not agree to meet anyone.
- Ask your teacher about any messages that you

- Do not attempt to access profane or obscene material. If you do so accidentally, notify your teacher right away.
- Do not enter inappropriate or hurtful

- language into the computer.
- Students will be disciplined according to the general disciplinary practices if they do not follow these guidelines or if they utilize the computers and Internet inappropriately.

## Misuse of Technology Recourses

Students are to use only programs and equipment as specified by their teachers. Students should not share their individual password with others.

Any student who is found tampering with
the computer system may be assigned out
of-school suspension on the first offense.
